Our chapter continues to thrive as a vital community of retirees and employees who remain deeply engaged with the ongoing growth and success of the University of Illinois Urbana-Champaign.

Looking back to our Spring Chapter meeting last April, we were honored to have Provost John Coleman share an inspiring update on *Boldly Illinois 2030: Building Our Future*. This ambitious strategic framework sets a bold vision for Illinois to become the preeminent public research university, embracing its land-grant mission while expanding its global impact. Provost Coleman articulated a powerful goal: to be “Best in the world at what we do and best for the world in what we do.”

Coleman also highlighted several key achievements that demonstrate this forward momentum. Enrollment has reached record highs, reflecting the university’s growing appeal. Online degree programs are expanding, making quality education more accessible than ever. National rankings continue to rise, underscoring our university’s academic and research excellence.

projects were discussed, including the new Wymer Hall on the Gies Business campus, a state-of-the-art animal cancer clinic on the veterinary medicine campus, and major renovations to historic buildings such as Altgeld Hall and Illini Hall. These developments reflect Illinois' commitment to advancing its facilities to support cutting-edge research and student success.

In July, the executive committee welcomed two new members: Megan Pearson, Library Services Coordinator at The Consortium of Academic and Research Libraries in Illinois (CARLI) and Katie Ross, Assistant Vice President, UI System Human Resource Services. Vice President Don Uchtmann and Program Committee Chair, Deb McCall were elected to second terms on the executive committee, and I thank them for their ongoing contributions.

Looking ahead, please mark your calendar for our Fall Meeting, scheduled for **Wednesday, October 29, at the I Hotel**. We are delighted to welcome David Bambrey from the University of Illinois Alumni Association as our featured speaker. This promises to be an engaging and informative event, and I encourage everyone to make plans to attend.

2025 SUAA State Annual Conference and Business Meeting

The SUAA State Annual Conference and Business meeting on June 13-14, 2025, was moved from its traditional location in downtown Springfield to the Uptown Normal Marriott Hotel. Delegates from our Chapter were able to attend a set of Breakout Sessions covering topics that ranged from personal issues such as health care and long-term care insurance to legislative issues including the Tier 2 Reciprocity Challenge. The sessions concluded with a discussion of the possibility of “Modernizing the Illinois Sales Tax” by expanding that tax to cover services. The presentation was similar to that presented at the Fall 2020 SUAA UIUC Chapter meeting by Ralph Martire, Executive Director for the Center for Budget and Tax Accountability.

The Annual Conference concluded with the Annual Business Meeting. The main agenda item at the meeting was the presentation of two amendments to the state Bylaws. The first proposed cancelling the Fall Meeting of the House of Delegates. The second proposed the creation of an at-large Chapter for SUAA members not affiliated with existing Chapters. After a relatively lengthy discussion, neither amendment was approved.



BIG RETIREES ASSOCIATION MEETING

University of Michigan, Ann Arbor, MI,
August 5-7, 2025

The Big Ten Retirees Association was formed in 1992 with the purpose of holding annual meetings at which the member associations could exchange information about what benefits they receive from their universities and/or states; how these organizations serve their members; and the services that these organizations and their members provide their universities. The 34th annual meeting at the University of Michigan on August 5-7, 2025, was attended by current Executive Committee members Tanya Gallagher and H. F. Williamson. A total of 31 delegates attended representing 15 of the 18 Big 10 Universities.

The meeting was well planned by our hosts from the University of Michigan Retirement Association. The theme was “Thriving Retirees Organizations: Doing Good, Not Just doing Well!” with the goal of sharing ideas and best practices for operating a successful retiree association. The first afternoon, there were two sets of plenary sessions covering “Topics of Common Interest” to our groups. These included such topics as Health Care Programs, Sponsorship; Staffing Support; Charitable Volunteering. Engaging Non-Local Members, and several others. This was followed by a walking tour of the central campus and dinner.

The breakout sessions continued the morning of the second day followed by a lunch presentation and the traditional bus tour of our host campus. The tour included a stop at the “Big House” (i.e., the football stadium) so we could walk on the field we see so often on television and tour the locker room. At dinner, we heard a dynamic presentation on “The Role of Positive Leadership in Helping Organizations Do Well and Do Good.”

On the morning of the third day, we attended the final plenary session that included a report from the University of Minnesota delegates noting that the planning is well underway for the 35th annual meeting of the group next August at their campus. Assuming the group continues to be active, it will be our turn in 2031 when we will be hosting the 40th annual meeting.

Frequently Asked Questions about the Campus Charitable Fund Drive

Thank you for your generosity!

Q. What are the dates of the 2025 CCFD Campaign?

A. The 2025 CCFD Campaign runs from September 17 to November 12, 2025. We will accept contributions from retirees for the 2025 CCFD campaign up until December 1, 2025.

Q. How do I donate?

A. Complete the form and return it with your check or money order. You may also make your pledge online at ccfd.illinois.edu. If your UIN is available, please have that number when you make an online contribution.

Q. What non-profits can I donate to?

A. You may donate to one of the ten CCFD agencies directly. You may also donate to any of the designated nonprofits listed under each agency. The complete list of CCFD agencies and their designations can be found at www.ccfid.illinois.edu/agencies

Q. Does my gift count towards the goal for the university department/unit from which I retired?

A. You may select which department/unit gets credit for your donation. The *Retiree Pledge Form* includes a box to indicate whom you would like to receive credit for your contribution.

Q. How is the release of information handled?

A. You may specify how or if you wish to be contacted. On the Pledge Form, select one of two boxes:

- ☐ I **DO NOT** wish to be contacted by the Agency
- ☐ I **DO** wish to receive acknowledgment from the Agency for my contribution

Q. I have given directly to United Way in the past and plan to continue this year. Can I receive CCFD credit for my direct contribution?

A. If your contribution to United Way occurs during the 2025 CCFD Campaign, it may be counted. CCFD works closely with the United Way of Champaign County to ensure both campaigns give the donor credit for their generous contribution. When giving to United Way, let them know you are a University of Illinois retiree (including department) and would like to receive CCFD credit for your donation.

If you give to United Way through the 2025 CCFD campaign, United Way will be informed of your gift.

Q. What if I want to give to a charity that is not listed as part of the 10 umbrella agencies?

A. CCFD no longer accepts write-in donations to organizations outside of our umbrella agencies. However, you can choose from nearly 700 approved nonprofits across the 10 agencies. Browse the full list at ccfd.illinois.edu/agencies.

SURS is our pension system. Once registered on the website, current employees will have access to historical pay and pension calculators to help plan for retirement. Information on programs such as buyouts is also available. After retirement, annuitants can view information about pension payments and deductions and can update addresses, beneficiaries, phone number, email address, and federal tax withholding status.

What has SUAA done for you?

PROMOTED HIGHER EDUCATION'S FUTURE INCLUDING THE FOLLOWING:

- Supported legislation in Springfield to strengthen health care and pension benefits for SURS members.
- Advocated for protecting and preserving the College Insurance Program (CIP health benefits).
- Protected faculty forced to take furloughs during the state's budget crisis.
- Worked to preserve Illinois' higher education system as a critical, quality commodity for Illinois, through the Higher Education Creates Jobs campaign and other advocacy.

Among other advocacy roles, SUAA continues to actively lobby the Legislature to prevent changes to the Constitution that would harm SURS retirees and active members, such as eliminating the "pension clause".

2026 SUAA Legislative Platform

The SUAA legislative platform serves as the guideline for our position on issues affecting funding for Higher Education, pensions, health insurance and benefits for SURS participants.

Through its Board of Directors and House of Delegates, SUAA will monitor, review, and evaluate proposed initiatives and legislation that may affect our members. SUAA will support legislation that aligns with the Mission Statement of SUAA and will oppose initiatives deemed contrary to the best interest of our membership base.

If legislation is passed that SUAA considers to be in violation of the pension protection clause of the Illinois Constitution, SUAA is prepared to take legal action in a court of law.

The foundation for the SUAA Legislative Platform will always be to protect and enhance retirement and health care benefits for all past, present, and future employees, along with their survivors, of Illinois' public universities and community colleges.

Protecting Tier I Benefits

- Ensure benefits are protected as stated in the Illinois State Constitution, specifically Article XII, Section 5 and affirmed by the Supreme Court of Illinois.
- SUAA supports proposals to fully fund the SURS Pension System.

Enhancing Tier II Benefits

- Fix Tier II Benefits to exceed the Safe Harbor Provision
- Fix Tier II Benefits so they are more closely aligned with Tier I Benefits

Healthcare Benefits

- SUAA supports full funding for the College Insurance Plan and opposes any reduction in coverage provided by that plan and the withholding of any funds appropriated for payment to retirees or providers.
- SUAA supports legislation to ensure that all public university and community college employees, retirees, and survivors are treated equitably under the State Employees Health Plan and College Insurance Programs.
- SUAA supports legislation that would allow participants in the TRAIL health care program to have multiple choices regarding the provider of their health care benefits.

Providing Strong Financial Support to Higher Education

- Increase and protect state and federal funding for Illinois' universities and community colleges.

Federal Legislation

- Protecting all aspects of the Social Security Fairness Act signed into law in 2025.
- Oppose any new taxation on public college and university endowments.

SURS and SUAA? What's the Difference?



SURS (State Universities Retirement System) administers benefits for the “public employee retirement system that provides retirement, survivor, disability, and death benefits for employees of Illinois state universities, community colleges, and certain other affiliated organizations and agencies.”

What does SUAA do?

- **SUAA** actively **advocates** to preserve and protect higher education, the SURS pension system, the healthcare plans, and other benefits provided for community college and university employees and retirees, their spouses and survivors. **SUAA** is not a union.
- **SUAA** is the only advocacy **organization** that focuses **solely** on protecting benefits for all **SURS** members and beneficiaries. In addition, **SUAA** works closely with **SURS** to educate employees about benefit changes resulting from recent legislation.

How do you become a member of these groups?

- **SURS** - As a university or community college employee, you automatically become a member of **SURS**. The cost is approximately 8% of your gross salary which is deducted from each and every paycheck.
- **SUAA**--*You must join SUAA* to become a member. **SUAA** has local chapters on each community college and state university campus in Illinois. **SUAA** annual dues may be paid by check (payable to **SUAA**) or credit card at www.suaa.org.

Why should you join SUAA?

- Joining **SUAA** is a way of taking responsibility for your own future, of doing something now to make sure that your retirement is there when you need it.
- Without your support, **SUAA** cannot protect your interests. The more members **SUAA** has, the stronger **SUAA**'s voice in Springfield.
